## Health Care Provider Education Sessions: Ontario Poison Centre Revised IV NAC Protocol

On April 1, 2026, the Ontario Poison Centre (OPC) will implement a revised IV acetylcysteine (NAC) protocol for the management of acetaminophen poisoning. This update brings our approach in line with national standards across Canadian poison centres and reflects extensive collaboration with pharmacists and clinical leaders in Ontario, Manitoba, and Nunavut.

To support a smooth and safe transition to the new protocol, the OPC will offer a series of education sessions for health care professionals in medicine, nursing, and pharmacy. We encourage participation from teams across all specialties involved in the care of patients with acetaminophen toxicity, including pharmacy, emergency medicine, internal medicine, hepatology/gastroenterology, and critical care.
